- 1.0 Call to Order & Pledge Allegiance to the Flag:** The meeting was called to order at 6:36 pm by Chair Steve Garcia
- 2.0 Approval of Minutes:** A motion was made by Kyle Schulty and seconded by Gilbert Flores to approve the minutes of the May 3, 2022 meeting. Approved 5/0/0
- 3.0 Special Guest:** Caltrans Public Information Officer Emily Leinen discussed the current status of the Hwy 18 and Hwy 189 repairs. She discussed time-frames for opening up both routes. She also discussed the long-term plan for a project on Hwy 189 next year.
- 4.0 Lake Gregory Community Advisory Committee Report:** Bill Mellinger discussed horseshoe pits, Bocce Ball courts, sod installation at the Meadow, Friday Night Market, and the new playground area. Waiting for new docks and ebikes. He also discussed the status of the sediment basins and the trail around the Meadow.
- 5.0 Community & Governmental Agency Updates:**
 - **San Bernardino County Sheriff:** Cpt. Lupear mentioned that calls for service are increasing as things get busier on the mountain. They are now doing off-road and lake patrols. Discussed recent trainings, the Tens system (reverse 911) and performing school security preparations and training.
 - **CHP:** Sgt Porter mentioned they are shorthanded locally and state-wide. He mentioned that Lt. Salinas is being promoted to Captain and will be stationed in Orange County. The new Commander at the Arrowhead Station is Lt. Napoleon Salais. Sgt. Porter also explained why there is always a CHP unit stationed at a closure.

- **Rim of the World Unified School District:** Dana Ridland and Bill Mellinger discussed recent and upcoming events. They also announced that a new Superintendent has been hired for the District. They discussed her experience. Rim SD has a current enrollment of just under 2800 students. They also shared information on the new Rim Virtual Academy.
- **Mountain Transit:** Kyle Schulty announced that Mountain Transit has a board vacancy and they are accepting applications.
- **Crestline Chamber:** Sara Green discussed the free trolley on Saturdays and Sundays, upcoming events and activities, a new visitor's guide, and new tourism website.
- **Senator Ochoa Bogh:** Sidney Sonck gave a legislative update and briefly discussed 10 bills submitted by the Senator.

6.0 Supervisor's Report: Lewis Murray discussed the upcoming Board of Supervisor's meeting related to Short Term Rentals. He also discussed the status of several County projects in the Crestline area, as well as the responsibility of homeowners to do their weed abatement.
